"Yunyu Kakunin-sho" Import of Medication Certification

<u>What is it?</u> The Yunyu Kakunin-sho, also known as the Import of Medication Certification, is a document that Japan customs may require upon arrival. The certification confirms that the prescription medication you brought with you is permitted to enter Japan. Even some over-the-counter medications and products require an Import of Medication Certification. Those who need to apply for the Yunyu Kakunin-sho should do so at least a month prior to departure as processing can take up to four weeks. If required, you <u>must</u> have this certificate with you when you arrive to Japan - no exceptions!

The following are permitted to be brought into Japan for personal use without a Yunyu Kakunin-sho:

Medication Type	Quantity allowed without Yunyu Kakunin-sho
Prescription medicines:	1 month supply or less (including birth control pills)
Non-prescription medicines and quasi-drug products:	2 month supply or less Up to 24 items each for products such as ointment, eye drops, antiperspirant, and toothpaste containing fluoride
Cosmetics:	24 items or less of each product *For example, if you bring lipstick into Japan, you can only have up to 24, regardless of brand or color
Vitamins:	4 month supply or less
Asthma Inhalers:	1 month supply or less
Disposable medical products: (e.g. sanitary items, disposable contact lenses)	2 month supply or less (for contact lenses, up to 60 pairs of daily disposable lenses); for external use products only
Medical devices intended for household use: (e.g. CPAP machine)	Up to one (1) set
Self-administered injection kit, pre- filled syringes (e.g. insulin): (*Please see note →)	1 month supply or less *As a rule, syringes and medications administered by injection, excluding self-administered injections of drugs such as insulin, are not allowed
Psychotropic drugs: (e.g. Ritalin)	Narcotics, Psychotropics, and stimulant raw material <u>are</u> subject to different rules and regulations.
* If bringing psychotropic medication, a prescription or documentation from a physician may be necessary regardless whether or not the amount you need exceeds the above limits.	Check here for allowable amounts for psychotropics. If your medication exceeds the amount listed on this chart, you will need to seek permission separately from the NCD (Narcotics Control Department). NCD has an Application Guidance page to help you determine which items require the NCD application form. The page also highlights what is prohibited from entering Japan.

Note from the JET Program Office: Please remember that medication readily available over the counter in the United States or another country may be illegal and prohibited from being brought into Japan. Please check if the medication you are taking is allowed in Japan and consult with your physician.

The following medical products are **restricted**, and **no amount may be brought into Japan:**



- Stimulants amphetamine, methamphetamine (INN: dexamphetamine, levamfetamine)
 - --- Adderall (contains amphetamine, dexamphetamine)
 - --- Nasal decongestant inhalants, such as Vicks[®] brand vapor inhalers (levamfetamine)
- Sudafed® (or any product containing more than 10% pseudoephedrine)
- Methaqualone

*JET participants are responsible for researching their own medications to verify whether or not they are legal in Japan. If you chose to bring more than the allowed amount of a medication into Japan, with or without a *Yunyu Kakunin-sho*, or attempt to bring in substances which are not legal in Japan, you do so at your own risk. In 2015, an American teacher (not with the JET Program) was jailed for attempting to smuggle in her Adderall prescription.

How to Complete and Submit the Yunyu Kakunin-sho

How to Complete and Submit:

Important: Please note that JET candidates must submit the Import of Medication Certification application directly to the Ministry of Health, Labour, and Welfare (MHLW) through their online processing portal. **Do not send the documents to the JET Program Office**.

To apply for a *Yunyu Kakunin-sho* Certificate, JET Programme participants must provide <u>all</u> of necessary forms to the Ministry of Health, Labour, and Welfare through their website's portal. If you do not have a *Yunyu Kakunin-sho* with you at the time of arrival and attempt to bring medications above the allowable limit into Japan, they may be confiscated.

Step 3: Secure an Itinerary Letter from your JET Coordinator / JET Program Office



If you need to apply for the Yunyu Kakunin-sho through the MHLW website, inform your JET Program Coordinator via email as your JET Program Office will need to provide you with an itinerary letter for your application. This letter must be attached to the "Invoice" section of your Import of Medication Certification application. Your JET Program Office will fulfill your request for an itinerary letter after being provided your flight information from Nippon Travel Agency (NTA).

Step 4: Submit the required information and all necessary forms to complete the application.
